

TERMS AND CONDITIONS

The price is for installation, hire and removal of edge protection only.

Any alterations required to the edge protection, need to be confirmed in writing and will be charged for at applicable man-hour rate and must only be undertaken by employees of Scope Building Safety Solutions Pty Ltd. Standard working hours (between 7am - 4pm) allowed only. After hour rates apply.

Any additional materials required will be charged at a linear meterage rate as quoted, plus 10% handling fee. Labour begins and ends at our yard, each day. All edge protection that is installed for a period of 1 month or more, may require a safety inspection by us, in accordance with Australian Safety Standards, or more often, pending site regulations. This will be charged at cost rate.

Our edge protection hire will commence once it leaves the yard and finishes once it is removed and returned to the yard. Initial edge protection hire is a minimum of 2 weeks and edge protection is hired out on a weekly/fortnightly basis thereafter. Delays onsite for example, waiting time, wet weather, etc. will be charged at an additional man-hour rate.

Craneage, forklift, traffic management requirements, safety fencing and fire protection at site cost and by site arrangements. Any delays caused on site as a result of poor accessibility to site or equipment will incur additional hourly labour charges.

Damaged or lost material on site will be charged for at replacement cost.

Site inductions longer than 15 minutes will be charged at the applicable hourly labour rate. GST will be in addition to these prices, unless stated otherwise.

Our edge protection is built to Australian Standards: AS/NZ S4994.12009.

We require a Work Order before work commences.

Our payment terms are 20% deposit to confirm your booking. Full payment is required 24 hours prior to installation. However, on acceptance of the quotation if an account is opened with Scope Building Safety Solutions Pty Ltd, we can negotiate up to 30 days payment terms from invoice. An account holder booking with Scope Building Safety Solutions Pty Ltd requires a non-refundable automatic 20% charge on your account on acceptance of quotation and booking confirmation. If the booking date is changed without due notice, the 20% charge will be taken and is non-refundable. Multiple amendments will incur an additional 20% fee per amendment.

Upon acceptance of your quotation, you have 24 hours to contact administration of Scope Building Safety Solutions Pty Ltd, in writing with any discrepancy, or the quotation will be deemed true and correct, and payment will need to be paid in full prior to installation.
